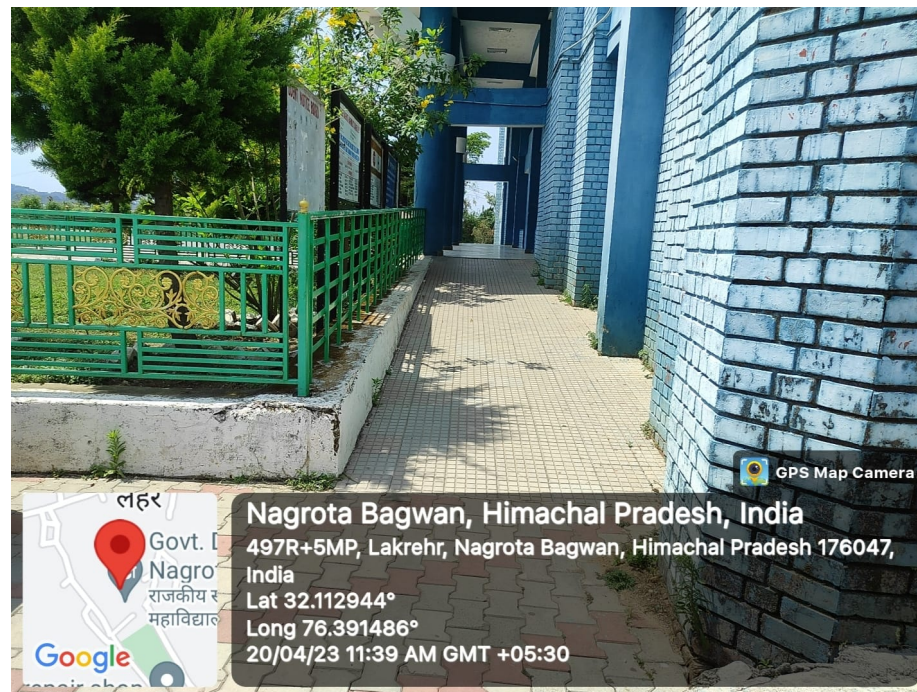

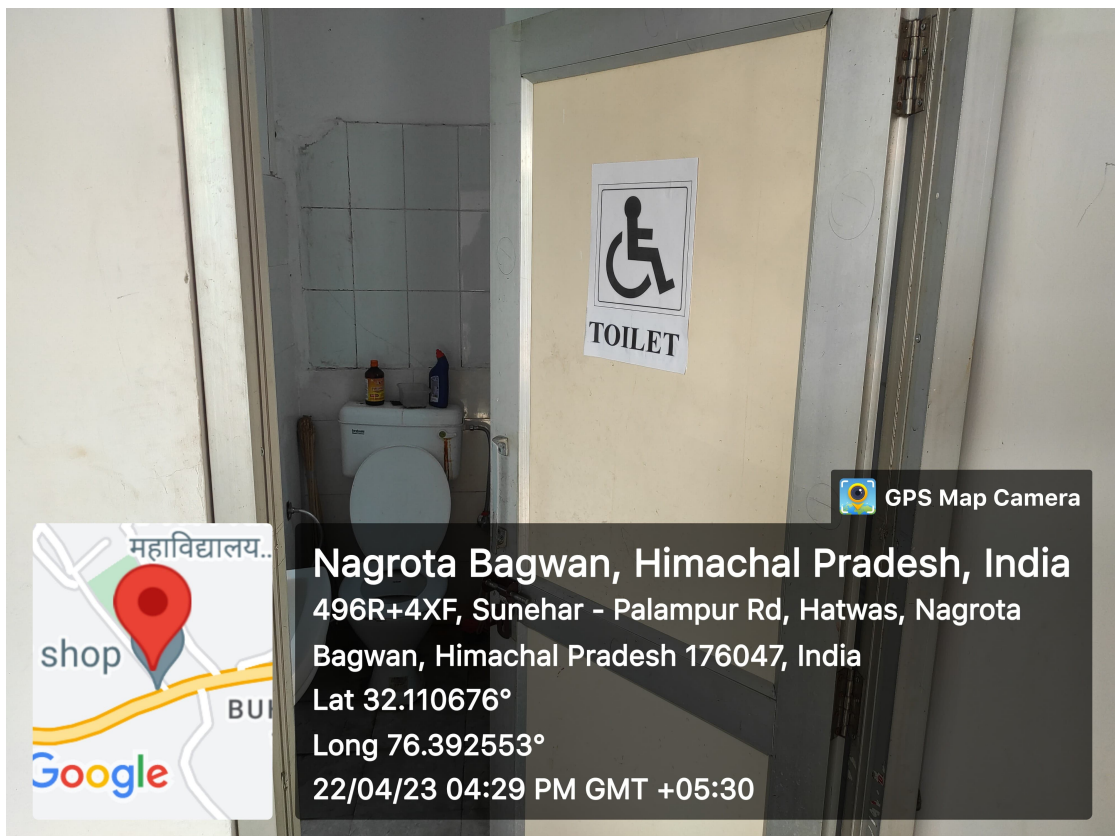

### NOTIFICATION

The Hon'ble Vice-Chancellor has been pleased to approve the following recommendations of the committee constituted for the Persons with Disabilities for conducting written examination with immediate effect:-


1. Criteria like Educational Qualification, Marks scored, age or other such restrictions for the scribe/reader/lab assistant should not be fixed. Instead, the invigilation system should be strengthened, so that the candidates using scribe/reader/lab assistant do not indulge in mal-practices like copying and cheating during the examination.
2. The word "extra time or additional time" that is being currently used should be changed to "compensatory time" and the same should not be less than 20 minutes per hour of examination for persons who are making use of scribe/reader/lab assistant. All the candidates with disability not availing the facility of scribe may be allowed additional time of minimum of one hour for examination of 3 hours duration which could further be increased on case to case basis.
3. The Principal of the colleges & Centre Superintendents is fully authorized to give permission for scribe.
