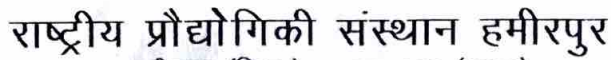

At the very outset Chairperson SDPC welcomed all the members present in meeting. The following agendas were taken up for discussions and necessary recommendations were made as given below:

1.	DDPC, DoMS (vide no. NIT/HMR/DOMS/PhD/2023 dated January 1, 2023) has recommended a case to Chairperson, SDPC to convert Ph.D. status from Full Time (FT-01) to Part Time (PT-02) of Research Scholar Ms. Maumita Bhattacharjee (2K19-PhD-MS-482) who has been offered a post of HR Specialist at KINS Infosoft, NOIDA.	Matter was deliberated in the meeting. Candidate has completed course work, residential requirement, passed comprehensive examination and delivered state of art seminar. The SDPC recommends Full Time (FT-01) to Part Time (PT-02) conversion of Ph.D. programme of Research Scholar Ms. Maumita Bhattacharjee(2K19-PhD-MS-482). Duly filled form DPP-06 is submitted. NOC from employer and proof of having research facility is also attached as per clause 5.5.2 of Ordinances for Doctoral Programmes.

2. DDPC, DoA (Vide no, NIT/HMR/Arch/2022/1173 dated January 4, 2023) has recommended a case to Chairperson, SDPC for semester leave application of Mrs. Manisha (2K19-PhD-Arch-475)→FT01 after availing maternity leave.
- Matter was deliberated at length in the meeting. Research scholar Mrs. Manisha (2K19-PhD-Arch-475)→FT01 was on maternity leave till 27-11-22. She was expected to join the institute on 28-11-22, but she has applied for leave without fellowship upto 05-01-2023 (39 days) stating the reason that she was not in a position to join the institute because extra care is needed for her baby. DDPC DoA has recommended the same under clause 12.6 of *Ordinances for Doctoral Programmes*, along with semester leave for running even semester under clause 12.4 of *Ordinances for Doctoral Programmes*. As the research scholar was on an unsanctioned leave for more than four weeks, SDPC returned the case in original for regularization of 39 days absence without sanctioned leave with justification and proofs.
3. DDPC, DoECE (vide no. NIT/HMR/CE-34(DDPC)/2022/2148-49 dated December 23, 2022) has recommended a case to chairperson, SDPC for withdrawal of admission of Ms. Chandani Dubey (22RECE001) stating the reason, she has got admission at IIT Delhi.
