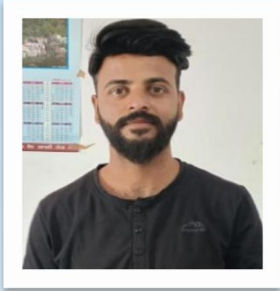

## GENERAL ADMISSION RULES FOR SELF-FINANCED COURSES

### ➤ Rules Regarding Seats, Eligibility Conditions, and Basis of Admission

#### Seats

The total numbers of seats in the BBA and BCA course are 60, distributes as under:

Category	Seats
Subsidized	60
<b>Total Seats</b>	<b>60</b>

#### Eligibility Criteria

Plus two examinations under the 10+2 system or examination equivalent thereof to a Board/University established by law in India with 45% marks (40% marks in case of Scheduled Caste/ Scheduled Tribe)

*Or*

Any examination of a University / Board / College or School in a foreign country recognized as equivalent for the above purpose by the Vice Chancellor / Equivalence Committee of its own or on the recommendation of the Association of Indian Universities AIU House, 16 Kalka Marg, New Delhi 110 002 with 45% marks. (40% marks in case of Scheduled Caste / Scheduled Tribe).

#### Basis of Admission

##### Subsidized Seats

Seats will be distributed on the basis of merit i.e. marks obtained in 10+2.As per HPU roaster.

##### Age Limit

Maximum age limit for admission to BCA course is 21 years for general category, 24 years for SC/ST category and 23 years for girl candidates, as on the 1st July of the year concerned. The Vice Chancellor may permit age relaxation up to maximum of three months.

##### Reservation

Admission to the course except for seats reserved for NRI's /NRI sponsored and foreign students shall be subject to the following conditions:

- a) 15% and 7.5% seats shall be reserved for Scheduled Caste and Scheduled Tribe candidates respectively, who have passed their qualifying examination from H.P.



Board of School Education, or any other school located within the territorial jurisdiction of Himachal Pradesh affiliated to any other Education Board e.g. CBSE or ICSE Board etc. However, reservation of seats will be governed by notification of the Government from time to time.

- b) The remaining 77.5% seats shall be filled as under: -
- i. 25% of the seats for admission to the course shall be open for all the candidates irrespective of the institution from which they have passed their qualifying examination.
  - ii. 75% of the seats shall be filled out of the candidates who have passed their qualifying examination from H.P. Board of School Education or any other school located within territorial jurisdiction of Himachal Pradesh affiliated to any other Education Board e.g. CBSE or ICSE Board etc. subject to the following reservation.
    - a) 5% of all seats shall be reserved for outstanding sportsmen.
    - b) 5% of the seats shall be reserved for the outstanding cultural activists.

### **End-Semester Examination (ESE)**

The remaining 70% of the final grade of the student in a course will be on the basis of an end semester examination (ESE) that will be for three hours' duration and will be covering the whole syllabus of the course.

#### **Note:**

1. Only those students will be allowed to appear in the ESE who has been successful in the CCA.
  2. A student, who fulfills all the requirements for appearing in a semester examination, is unable to appear in the examination or to complete it on account of his/her own serious illness, accident, or on account of the death of near relative (mother, father, brother and sister), or the dates of state or national level examinations falls on dates of the semester exams may be allowed to appear in the semester exam in the next academic year when examination for that semester is due.
  3. Permission to sit in the examination will be permitted by college Principal/Director on the production of a valid certificate/document from the competent authority. The college will send the name of the student to the Registration and Migration Cell for information.

## **General Rules for Leave/Fee /Fine**

### **Leave Rules**

#### **a) General Leave Rules**

- Student can proceed on leave with prior permission. For this, they should fill in the leave forms to be supplied to the students Rest. 5. A maximum of 5 days' leave is allowed in a semester. A tutor can recommend leave up to 3 days; for longer duration i.e. up to 5 days, a student must get the application signed by the Principal of the programme.
- Leave during House Examination / Class Tests should be avoided, if unavoidable will be sanctioned only by the Principal on the recommendation of the Coordinator.
- Leave for sickness must be accompanied by a medical certificate.

### **FEES/FUNDS/FINES**

1. a) Every student must pay his/her dues on the dates notified from time to time. A student will have to pay the First Installment of dues at the time of admission for 1<sup>st</sup> semester and for the rest of the semesters, the fee should be paid before the beginning of the respective semester.

a) Failure to pay dues on the due date will entail a fine of Rs. 100/-per day.

b) In case of non-payment of dues, the name of the student will be struck off from the rolls at the end of that month.

c) Registration fee will not be charged to student migrating from another college if he is already registered with H.P. University. Other dues will have to be paid from the month of joining this institution provided the student has not paid the dues in the college from which he has migrated.

2. The name of a student will be struck off from the rolls of the college if he/she remains absent without leave for ten days or more in any class/subject (Theory/Practical).

3. At the end of the semester fine of Rs.5 per lecture and Rs.25 per a day will be charges on 100% of attendance.

4. Every student will have to procure No Dues Certificate from the Library, NCC, NSS, Sports, Hostel, College Canteen, Fee Clerk, etc. if he wants to leave the college.

5. The Principal can expel a student from the college if he/she is found guilty of misconduct.

6. The security deposit will lapse if a student does not apply for a refund of security within one year of leaving the college.

## **Re-Admission**

1. In case the name of a student is struck off, the re-admission is permissible within 1<sup>st</sup> seven days with first re-admission fee of Rs. 200/- on a prescribed Performa. If the student fails to seek re-admission within first seven days then he/she should seek re-admission within 12 days, on payment of Rs. 500/- as second re-admission fee on the personal presence of parent/guardian. After 12 days from the date of his/her name is struck off, there shall be no re-admission in any condition.
2. If the name of the student is struck off again then 2<sup>nd</sup> re-admission fee is Rs.500/- and if the name of the student is struck off 3<sup>rd</sup> time, there is no provision for re-admission.

## **Facilities:**

### **The Library**

- Library Card should be collected from the Librarian as per schedule notified by the librarian.

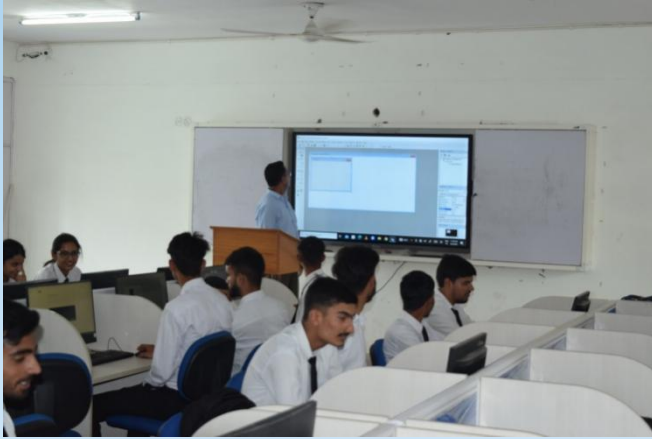

- University Registration of Rs. 200 (for HP board students) and Rs.400 (for other board) will be charged at the time of registration.

## CODE OF CONDUCT

1. The Decision of Principal in all matters will be final and binding.
2. Students must be seated in the classrooms before the start of the lecture. No student shall enter the class or knock the door after 5(five) minutes of start of the class.
3. No student shall be loitering near the classes once the classes are in progress.
4. Regular attendance in the class including guest lecturers is compulsory.
5. Use of Mobile Phone is strictly prohibited in the college premises. A student using mobile phone in classroom/lab will be fined Rs.500/- and no exemption will be given in any case.
6. Every student will submit assignments; project etc. as per periodic directions.
7. Misbehavior, Persistence disobedience, habitual late coming, consumption of drug or liquor in the institute, cheating in the examination and any unbecoming act may invite strict disciplinary action including expulsion from the institute.
8. Each student is expected to observe the college dress code strictly.
9. Each student is expected to be present regularly in the college. Name will be struck-off if a candidate absentee himself continuously for six days. Candidates can get re-admission after satisfying the Principal.
10. No student is permitted to undertake any part time/whole time job during the course of study.
11. No student is allowed to put posters in college campus or notice board and to hold assembly in college premises or to address on unauthorized assembly in the college campus.
12. Any student making loss to the college property will be penalized and the students concerned will have to replace or get the same repaired at his/her own cost.
13. Food, breweries and any type of drink are not permitted in the lab/classrooms.
14. Students are not allowed to leave the college campus during teaching hours without prior permission.
15. Parents will be intimated about the progress of their ward periodically through report card and personal feedback.
16. Every student must always carry with him/her duly completed identity card.

## **Ragging and Anti-Social Activities**

Ragging in institute is strictly banned according to the judgment and directions of the Hon'ble Supreme Court of India, Himachal Pradesh University and guidelines issued by UGC in this regards. The following guidelines will be observed to prevent incidents of ragging in the institute.

1. Every candidate seeking admission will give an undertaking duly printed on the application form that he/she will not indulge in ragging and if found guilty he / she will be liable for punishment. A similar undertaking will be obtained from the parents / guardians of applicant. (Fill Annexure-I and II )
2. Anti-Ragging committee has been constituted in the college.
3. Whenever a ragging incident is brought to the notice of college authorities, the disciplinary committee will hold an enquiry into the incident.
4. If any student is found guilty of ragging after the enquiry then he / she will be punishable accordingly. The punishment may include :-
  - i) Expulsion from the College
  - ii) Suspension from the classes
  - iii) Fine with a public apology
  - iv) With holding scholarship or other benefits
  - v) Debarring from the representation in events
  - vi) Suspension or expulsion from hostel or mess
  - vii) Legal proceeding under criminal law shall be initiated
5. If any student is found guilty of ragging incident occurred in the past then he/she may be expelled from the institution.

## **RAGGING AND ANTI-SOCIAL ACTIVITIES**

This College is committed to a zero tolerance policy towards:

### 1. Ragging:

Ragging is a punishable offence. Ragging of all kind is strictly banned in the college campus. Anybody caught indulging in this evil exercise shall face penalty under the law. Act remotely suggestive of ragging should be reported to the college authorities/to the member of anti-ragging committee. A student who commits the offence of ragging shall be punishable with imprisonment for a term, which may extend to three years or shall or both.
